(2) - \$100 per active CACC TA license holder if travelling to Knox Mountain Hill Climb to volunteer\* in the event and travelling from or outside the GVRD (Ferry travel or more than 300km away). To be paid at the end of the season and up to a maximum of \$700 (100x7) total reimbursement from the club for the season. If more than 7 requests are made, the funds are to be split evenly on % basis. All applicants must apply before Oct 31date.

\*Must only be volunteering for the weekend (not just one day).
